

NOTICE OF PUBLIC MEETING

WALKER COUNTY EMERGENCY SERVICES DISTRICT NO. 3

Notice is hereby given pursuant to the Texas Government Code, Chapter 551, as amended, that the Board of Commissioners (the "Board") of Walker County Emergency Services District No. 3 (the "District") will conduct its regular meeting, open to the public, at **6:30 p.m., Friday, August 12, 2022**, at the **Crabbs Prairie Volunteer Fire Department, 28 FM 1696, Huntsville, Texas 77320**, a location inside the boundaries of the District, at which meeting the following matters will be considered and acted upon:

1. Call meeting to order;
2. Roll call;
3. Public comment;
4. Approve minutes of July 8, 2022 regular meeting;
5. Confirm engagement of auditor for preparation of Fiscal Year Ending ("FYE") September 30, 2022 audit report;
6. Bookkeeper's Report, including:
 - a. authorize payment of bills/invoices; and
 - b. discuss draft FYE September 30, 2023 Budget;
7. Tax Assessor's Report;
8. Review 2022 Tax Rate setting process and proposed tax rate, authorize publication of proposed tax rate and set public hearing date, if necessary;
9. Crabbs Prairie Volunteer Fire Department ("CPVFD") Fire Chief's Report, including:
 - a. fire operations;
 - b. status of the Crabbs Prairie Fire Station construction and take any necessary actions on same;
 - c. review CPVFD budget of operations and capital expenditures for FYE September 30, 2023 and take any necessary actions on same; and
 - d. status of procurement of District capital items through America Rescue Plan Act funding;
10. Webmaster's Report;
11. Attorney's Report, including:
 - a. review *City of Huntsville vs. the District* matters; and
 - b. review District future structure options;
12. Executive Session pursuant to Chapter 551, Texas Government Code, (Open Meetings Act) to discuss matters, as may be necessary; and
13. Adjournment.

The Board of Commissioners is authorized by the Open Meetings Act to convene in closed or Executive Session for certain purposes. These purposes include: receiving legal advice from its attorney(s) pursuant to §551.071, Texas Government Code; discussing real property matters pursuant to §551.072, Texas Government Code; discussing gifts and donations pursuant to §551.073, Texas Government Code; discussing personnel matters pursuant to §551.074, Texas Government Code; and, discussing security personnel or devices pursuant to §551.076, Texas Government Code. If the Board decides to enter into Executive Session regarding any item on this agenda, the Presiding Officer will announce that an Executive Session will be held and will identify the item to be discussed and provision of the Open Meetings Act that authorizes the closed or Executive Session.
