

## AMENDED NOTICE OF PUBLIC MEETING

Notice is hereby given pursuant to the Texas Government Code, Chapter 551, as amended, that the Board of Commissioners (the "Board") of Walker County Emergency Services District No. 3 (the "District") will conduct its regular meeting, open to the public, at 6:30 p.m., Friday, April 8, 2022, at the Crabbs Prairie Volunteer Fire Department, 28 FM 1696, Huntsville, Texas 77320, a location inside the boundaries of the District, at which meeting the following matters will be considered and acted upon:


1. Call meeting to order;
2. Roll call;
3. Public comment;
4. Approve minutes of March 11, 2022 regular meeting;
5. Discuss and take necessary action in connection with receipt of American Rescue Plan Act of 2021 funds from Walker County;
6. Bookkeeper's Report and authorize payment of bills/invoices;
7. Review Investment Policy and authorize establishment of account(s) in investment pool(s), as may be necessary;
8. Tax Assessor's Report;
9. Crabbs Prairie Volunteer Fire Department Fire Chief's Report, including:
  - a. fire operations; and
  - b. future building/capital needs for the Crabbs Prairie Fire Station and take any necessary actions on same;
10. Webmaster's Report;
11. Attorney's Report, including review *City of Huntsville vs. the District* matters;
12. Executive Session pursuant to Chapter 551, Texas Government Code, (Open Meetings Act) to discuss matters, as may be necessary; and
13. Adjournment.

The Board of Commissioners is authorized by the Open Meetings Act to convene in closed or Executive Session for certain purposes. These purposes include: receiving legal advice from its attorney(s) pursuant to §551.071, Texas Government Code; discussing real property matters pursuant to §551.072, Texas Government Code; discussing gifts and donations pursuant to §551.073, Texas Government Code; discussing personnel matters pursuant to §551.074, Texas Government Code; and, discussing security personnel or devices pursuant to §551.076, Texas Government Code. If the Board decides to enter into Executive Session regarding any item on this agenda, the Presiding Officer will announce that an Executive Session will be held and will identify the item to be discussed and provision of the Open Meetings Act that authorizes the closed or Executive Session.
