and all of said persons were present, except Commissioner(s) Garner, thus constituting a quorum. Whereupon, among other business, the following was transacted at the meeting:


ORDER ADOPTING BUDGET FOR FISCAL YEAR ENDING SEPTEMBER 30, 2021

WHEREAS, WALKER COUNTY EMERGENCY SERVICES DISTRICT NO. 3 (the "District") is a political subdivision of the State of Texas, organized as provided by Article III, Section 48-e, of the Texas Constitution and by Chapter 775, Texas Health and Safety Code (the "Code"), and operating pursuant to Chapter 775 of the Code; and

WHEREAS, pursuant to Chapter 775 of the Code, the District is required to adopt an annual budget for each fiscal year; and

WHEREAS, the Board of Commissioners of the District has previously determined that the District's fiscal year will be October 1 through September 30 of each year.

NOW, THEREFORE, BE IT ORDERED BY THE BOARD OF COMMISSIONERS OF WALKER COUNTY EMERGENCY SERVICES DISTRICT NO. 3:
