ORDER SETTING RATE AND LEVYING TAX FOR 2024

WHEREAS, Walker County Emergency Services District No. 3 (the "District") is a governmental agency and body politic and corporate of the State of Texas created pursuant to Chapter 775, Texas Health and Safety Code to accomplish the purposes provided by Section 48-e, Article III, Texas Constitution (the "Article"); and

WHEREAS, the Article states that the District has all the rights, powers, privileges, District, functions and duties necessary convenient to accomplish the purposes of Chapter 775, Texas Health and Safety Code, as amended; and

WHEREAS, Section 48-e, Article III, Texas Constitution allows for the levy of an ad valorem tax on property in the District not to exceed ten cents (\$0.10) per \$100 valuation for the support of the District, which has been approved by a vote of the qualified voters of the District; and

WHEREAS, Sections 26.04, 26.05 and 26.06, Texas Tax Code, as amended, provide that before the Board adopts an ad valorem tax rate, the Board shall give proper notice of each meeting of the Board at which the adoption of a tax rate will be considered; such notice of the public hearings on the District's tax rate shall be substantially in one of the forms set forth in Sections 26.06, 26.061 and 26.062, Texas Tax Code, as amended, and shall be published in a newspaper having general circulation in the District at least five (5) days before the date of the hearing; and

WHEREAS, if the Board adopts a total tax rate that would exceed the greater of the District's voter approval tax rate or *de minimis* rate, the District shall be required to hold an election to determine whether to approve the adopted tax rate in accordance with the procedures provided by Texas Tax Code, §\$26.07 and 26.081 and subject to the allowance for a petition for a rollback election to determine whether to reduce the tax rate adopted by the District to the voter-approval tax rate under Texas Tax Code, §26.075; and

WHEREAS, the Tax Assessor and Collector for the District has received the certified tax roll from the Walker County Appraisal District providing the 2024 taxable valuation of District property and presented such information to the Board for its consideration in setting the 2024 tax rate, including the 2024 tax rate calculations prepared by the Walker County Appraisal District which includes the debt service and maintenance and operations components thereof, if any; and

WHEREAS, the Board finds that the tax levy is necessary for operations and maintenance purposes of the District and is permitted by the Texas Constitution.

NOW, THEREFORE, BE IT ORDERED BY THE BOARD OF COMMISSIONERS OF WALKER COUNTY EMERGENCY SERVICES DISTRICT NO. 3, THAT:

- <u>Section 1</u>. The Board hereby finds that prior to adopting the ad valorem tax rate for 2024, the District has provided all proper notices of the public hearings required to set the District's tax rate and has otherwise satisfied the requirements of Section 26.06, Texas Tax Code, as amended.
- <u>Section 2</u>. The Board hereby levies and causes to be assessed upon all property (real, personal or mixed) subject to taxation within the District a total ad valorem tax rate of \$0.10000 per \$100 of assessed value for the 2024 tax year.
- <u>Section 3</u>. The total ad valorem tax rate is only comprised of \$0.10000 per \$100 assessed valuation for operations and maintenance purposes.
- Section 4. Walker County Appraisal District, the District's Tax Assessor and Collector, shall take all steps necessary and authorized by law to collect taxes as owed pursuant to this Order. Said ad valorem taxes shall be levied, assessed and collected at the rate of \$0.1000000 per \$100 of assessed valuation as provided for in Chapter 775, Texas Health and Safety Code, and all other applicable laws.
- Section 5. THE DISTRICT'S TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE. THE DISTRICT'S TAX RATE WILL EFFECTIVELY BE INCREASED BY 27.58 PERCENT (27.58%) AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$21.62.
- Section 6. Pursuant to State law, all taxes shall be due and payable on or before the 31st day of January, 2025.
- <u>Section 7</u>. The President or Vice President is authorized to do all things necessary for execution of this Order; and the President or Vice President is further authorized to execute, and the Secretary or any Assistant Secretary to attest, this Order on behalf of the Board of Commissioners.
